SOPVA and IIVET-Shillong (liquidated) has initiated to offer a Certificate Programme in Folk Theatre and Performances of North East India and the old Phase-I, Phase-II and Phase-III were approved on 19th August, 2009, 20th April, 2011 and 18th July, 2011. Due to delay in preparing the study material Phase-IV (old) not approved. Since the study material is now ready and when approached to P&DD for new course codes for the revised structure of the programme it is informed that the present programme needs approval of all the new phase forms for the launch. So the new phase-1 form for the same is placed before the School board for consideration and approval.

Recommendations: After deliberations Prof. Nita Mathur suggested to elaborate the details of concept note in terms of rationale and relevance vis-à-vis IGNOU objectives in Phase-I form, and the Phase-I for Folk Theatre and Performance of North-East India was approved.
