



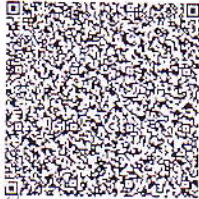



RENEWAL AGREEMENT


This "Renewal Agreement" (Here-in-after referred to as the "Renewal Agreement") is executed on this the 2nd day of March, 2021, at New Delhi,




HERE-IN-AFTER, individually referred to as the "**Party**" and collectively referred to as the "**Parties**".






