- SB.39.1.3 The Board confirmed the Minutes of the 38thMeeting of the School Board held on 13.10.2021 and the Action Taken Report of it (Annexure-1).
- Agenda No. To consider and approve the Programme Development Form (PDF) and SB. 39.2: Programme Project Report (PPR) of the "B.Sc. in Food Safety and Quality Management" programme.
- SB.39.2.1 Prof. S.K. Yadav, Chairman, informed that the School is developing a "B.Sc. in Food Safety and Quality Management" programme.
- SB.39.2.2 The Programme Coordinators, Dr. P. Vijayakumar and Dr. Mukesh Kumar, presented that the Exploratory Expert Group meeting held on 24-09-2021 and two Expert Group Meetings held on 25-10-2021 and 12-11-2021 have made detailed deliberations on the need of the programme, title and objectives of programme, target group, eligibility (Minimum qualifications) and programme structure (credits load and number of courses).

The PPF of this programme has been approved by the School Board of the School of Agriculture in its 38th meeting held 13th October 2021 and the Academic Programme Committee (APC) in its 62nd meeting held on 16.12.2021.

The Programme Coordinator further informed that the Programme Development Form (PDF) and the Programme Project Report (PPR) of the B.Sc. in Food Safety and Quality Management are submitted herewith for consideration and approval of the School Board and after its approval the same will be placed before the next meeting of the Academic Council of the University for its consideration and approval.

SB.39.2.3 The School Board approved the Programme Development Form (PDF) and Programme Project Report (PPR) of the "B.Sc. in Food Safety and Quality Management" programme (Annexure-2).

SB.39.5.1

The Programme Coordinator, Dr. Mita Sinhamahapatra, presented this agenda item and informed that the concept note for the proposed programme was approved in the 25th School board meeting held on 13.03.2015. The proposed M.Sc programme will have a modular approach i.e. after successful completion of the 1st year, a learner can have the PG Diploma in Food Safety and Quality Management (PGDFSQM) and the pass outs of the existing PGDFSQM programme will be eligible for lateral entry in the 2nd year of the M.Sc. programme. She also presented the target group, evaluation methodology, etc. of this programme.

She further informed that the Programme Proposal Form (PPF) of this proposed programme was approved by the School Board (through circulation on 25.11.2021) and the APC in its 62nd Meeting held on 16.12.2021.

Dr. M.V.L. Reddy suggested that as we are following the guidelines of the UGC which are related to the National Education Policy 2020 and in the same manner, why don't we make Bachelor's Degreea 4-year Degree programme instead of 3-year whereby multi-disciplinary degree programmes would be offered and those students who complete the graduate level degree can enrol in IIISemester of this Master's Degree. Dr. S.K. Yadav welcomed the suggestion and informed that as this is a policy decision and this University has not yet adopted such mechanism till date, the same may be taken up once the policy is in place.

SB.39.3.2 The School Board approved the Programme Development Form (PDF) and Programme Project Report (PPR) of the "M.Sc. in Food Safety and Quality Management" programme (Annexure-3).

Agenda No. To consider and approve the panel of paper setters for ODL, MOOCs and SB. 39.4: Online exam of Post Graduate Certificate in Agriculture Policy (PGCAP).

SB. 39.4.1 The Programme Coordinator presented the panel of paper setters for ODL, MOOCs and Online exam of Post Graduate Certificate in Agriculture Policy (PGCAP).

Dr. S.K. Yadav informed that as per the suggestion of the Prof. N.C. Gautam, the School will develop a bank of experts in future.

Dr. P.K. Jain submitted that three more Experts have been identified and added with this panel.

SB. 39.4.2 The Board approved the panel of paper setters for ODL, MOOCs and Online exam of Post Graduate Certificate in Agriculture Policy (PGCAP), along with three more names as suggested by Dr. P.K. Jain (Annexure-4).

Agenda No. To consider and approve the list of paper setters and evaluators for the different SB.39.5: MOOCs of the School.

The Chairman of the Board informed that the School is offering different MOOCs through SWAYAM. For their examination, a list of Paper Setters and Evaluators has been prepared for each MOOC separately. The MOOCs include: 1.Introduction to Poultry Farming (OLP-001); 2.Food Laws & Standards; 3. Awareness Programme on Solar Water Pumping System.

Dr. M.V.L. Reddy asked if these courses are part of IGNOU's regular Programme, so that the already approved paper setters and evaluators may be used for the MOOCs as well. Dr. Mita Sinhamahapatra informed that NTA conducts the Term-End-Examination (TEE) of the MOOCs and the Question Paper pattern is different from that of ODL TEE, hence the approval of a separate panel is required for MOOCs.

- Agenda No. To report the development of "Diploma in Agriculture Cost Management" SB.39.8: jointly by the IGNOU and the Institute of Cost Accountants of India (ICAI).



SB.39.8.1

It was presented that the Institute of Cost Accountants of India has desired development of a Diploma in Agriculture Cost Management programme with IGNOU to impart the knowledge & skills among the youth in agril sector such as farm accounting and costing, agril supply chain management, prudent utilization of land, deployment, water budgeting, and other associated farming activities. Further, it would also impetus entrepreneurial capabilities to the potential aspirants.

To finalize the modalities of programme development, a meeting of officials of IGNOU and the ICAI was held on 22 Nov.2021. The broad structure and other aspects of programme were discussed in the meeting.

Prof. N.S.R. Sastry suggested to include Animal Husbandry as a part of Agriculture.

Dr. Ramesh Mittal suggested that for validation of the outcome, one member from the CACP may join in the development of this programme.

SB.39.8.2 The School Board noted the development of "Diploma in Agriculture Cost Management" jointly by the IGNOU and the Institute of Cost Accountants of India (ICAI).
