A total of 23 candidates were shortlisted for interview against four vacant seats (three General category and one OBC-NCL category). The interview of shortlisted candidates for admission to Ph.D in Nursing for July, 2021 session was held on 4th May, 2022. Out of 23 candidates only 16 candidates appeared in interview (12 Gen and 04 OBC-NCL). The criteria for evaluation of candidates was followed as per guidelines provided by the Research Unit, IGNOU. The weightage for entrance examination was 70, percent and for the interview weightage was 30 percent. The candidates were assessed in the interview out of 30 marks as per the guidelines which included Research Methodology; 40% Subject Knowledge; 40% followed by Communication Skills; 20%. The Minutes of the Interview Committee were also presented to the School Board Members as Appendix 1.

Prof. Pity Koul, Director, SOHS & Programme Coordinator further informed that the Doctoral Committee approved the minutes of the interview committee regarding recommendation of following candidates for admission to PhD in nursing for July 2021 session.

After detailed deliberations and discussions, the Expert Committee observed that the whole content of CCH is matching with the existing theory and practical course curriculum of B.Sc.N (PB) IGNOU and recommended the strategy of integration of CCH Programme Core competencies in Community Health Nursing BNSL-209 of 3rd year Post Basic B.Sc. Nursing Programme of IGNOU with adoption of 4 credits from BNSL 043 and adoption of Logbook as a whole.
