Prof. Kumar B. Das, Prof. Preet Rustagi and Dr. Pradeep Kumar couldnot attend the meeting.

Dr. Nehal A. Farooquee, Director, SOEDS while welcoming all the Members briefed them about the item-wise action taken on the various Agenda Items of the last (14th) School Board Minutes and current position with regard to the Academic Programmes of the School. This was followed by item-wise discussion on the agenda items. The outcomes of the 15th School Board Meeting are enumerated below.

SB 15.1 Confirmation of Minutes of the 14th School Board held on 08.02.2013.

SB 15.1.1 The Members confirmed the Minutes of 14th School Board Meeting.

SB 15.2 To consider and approve the Phase-3 form (Programme Launch Approval Form) of Post Graduate Diploma in Urban Planning and Development (PGDUPDL).

SB 15.2.1 The Programme Coordinators informed the members the following status of PGDUPDL:

- Phase-1 and Phase-2 forms were approved by Academic Council on 20.04.2010.
- MPDD store has received printed course material for two courses (MEDS 41 and MEDS 44). The rest of the 3 courses, project work and programme guide material are in Press and are expected to be delivered by September 2013 as per MPDD assurance.
- Brochures and Posters have printed and sent to all RCs
- Filled in forms have been submitted to SRD for admission data entry software.

- Four RCs have activated study centres in Trivandrum, Delhi, Patna and Bhubaneswar.
- 2 out of 4 audio programmes and 3 out of 4 video programmes have been recorded. The leftover shall be completed by September 2013.

After deliberations and keeping in view of the readiness of the programme, Members approved the Phase-3 Form (Programme Launch Approval Form) of PG Diploma in Urban Planning and Development.

SB 15.3 To consider and approve the Evaluation Methodology for the Post Graduate Diploma in Urban Planning and Development.

SB 15.3.1 The Programme Coordinators explained to the members the following details of the Evaluation Methodology:

- Weightage for continuous evaluation: 30 % (Assignment)
- Weightage for continuous evaluation: 70 %
- Weightage for Project Report : 100 %
- Evaluation under Numerical Marking
- Minimum Marks to be obtained in each course and overall : 40 %

The Members after deliberations approved the Evaluation Methodology for PG Diploma in Urban Planning and Development.

Action: Evaluation Methodology to be sent to SED for Software Development

SB 15.4 To consider and approve the list of Paper Setters, Moderators and Evaluators for the Post Graduate Diploma in Urban Planning and Development.

SB 15.4.1 The Programme Coordinators informed the members that as per University norms course wise list of question paper setters / moderators / evaluators is to be communicated to SED. Accordingly the lists of experts for MEDS 041, MEDS 042, MEDS 043, MEDS 044 and MEDSP 045 have been prepared and annexed. As per modalities prescribed in the Project Handbook for MEDSP 045, the Project Proposals will be evaluated by School Faculty at Head Quarters, whereas SED will get the evaluation of Project Reports through the list of evaluators submitted by the School.

The Members considered and approved the panel of Paper Setters, Moderators and Evaluators for the Post Graduate Diploma in Urban Planning and Development.

SB 15.5 To consider and approve the list of Paper Setters, Moderators and Evaluators for the Post Graduate Certificate, Diploma and MA in Extension and Development Studies.

SB 15.5.1 The Programme Coordinators informed to the members that Paper Setters, Moderators and Evaluators for the Post Graduate Certificate, Diploma and MA in Extension and Development Studies have been approved while launching the programmes in 2010. The updated lists are annexed for the approval of School Board.

However Research Unit has requested to provide course-wise list of approved paper setters and moderators to streamline the TEE of PhD coursework. Accordingly the panel of Paper Setters, Moderators and Evaluators for REDS 001, REDS 002, REDS 003, REDS 004 and MEDS 001 are annexed for approval.

The Members considered and approved the panel of Paper Setters, Moderators and Evaluators for Ph.D. in Extension and Development Studies.

SB 15.7 To consider and approve the list of Paper Setters, Moderators and Evaluators for the Post Graduate Diploma in Development Studies.

SB 15.7.1 The Programme Coordinators informed to the Members that the course material for Post Graduate Diploma in Development Studies is under preparation. The panel of experts for MDV 001, MDV 002, MEDS 003, MEDS 009, MDVE 001, MDVE 002, MDVE 003, MDVE 004, MDVE 006 MDVE 005 and MDVP 001 are annexed for approval. As per modalities to be prescribed in the Project Handbook for MDVP 001, the Project Proposals will be evaluated by School Faculty at Head Quarters, whereas SED will get the evaluation of Project Reports through the list of evaluators submitted by the School.

The Members considered and approved the panel of Paper Setters, Moderators and Evaluators for Post Graduate Diploma in Development Studies.

SB 15.8 To consider and approve the Evaluation Methodology for the Post Graduate Diploma in Development Studies.

- Weightage for continuous evaluation: 30 % (Assignment)
- Weightage for continuous evaluation: 70 %
- Weightage for Project Report : 100 %
- Evaluation under Numerical Marking
- Minimum Marks to be obtained in each course and overall : 40 %

The Members after deliberations approved the Evaluation Methodology for Post Graduate Diploma in Development Studies.

SB 15.10.1 The Programme Coordinators have explained to the Members that the Vice Chancellor instructed to review the MAEDS/ PGDEDS/ PGCEDs with the help of external experts to enhance the enrollment. Accordingly a review meeting was held on 17.05.2013.

SB 15.12 To consider and approve the Minutes of the Doctoral Committee meeting held on 13.05.2013.


SB 15.12.1 The Research Programme Coordinator appraised the Members briefly the following items approved by Doctoral Committee:
