Consider and approve revised syllabus B.A. (Philosophy) in BDP programme

SB.21.3.1

The programme coordinator Prof. Nandini Sinha Kapur informed the school board that the Philosophy electives have been offered in BDP for the last 8 years. As the BDP programme needed to be offered in CBCS system as per the UGC norms, the expert committee meeting was conducted on 28th Feb, 2017 to revise the syllabus and the revised syllabus is placed before the board for consideration and approval. The members perused the syllabus and suggested that the course with 8 credits can be split into two courses of 4 credits. Also, they opined that the course should account for the credit load uniformly in terms of no. of blocks and units. The programme coordinator clarified that the number of the units in a block can be either 3/4/5. However, the weightage in terms of credits for each block will be same.

The School Board recommended that the SOITS go ahead and offer the PGDLD programme as a stand-alone programme to begin with. The SB noted that the Certificate Programme in Labour and Development earlier offered by the SOSS was no longer available and therefore the PGDLD programme would be of benefit to the Learners. The members suggested for hiring a consultant in the field of labour and development for the successful launch of the programme.
