Item no 25.08: To approve the modality of TEPE for Certificate programmes in Painting, Applied Arts, Bharatanatyam, Hindustani Music, Karnatak Music and Theatre Arts being offered by SOPVA during Covid lockdown period Jan 2020 and July 2020

NOTE

As is known that the Nation is observing Lockdown to curb the ongoing menace of Covid 19. In this situation School of Performing and Visual Arts, a school with different needs for delivery and evaluation process, has continued to deliver its programmes through Web Enabled Academic Services (WEAS), Google Classroom (TELS) etc. relentlessly. The counselling and

assessments for all Certificate programmes i.e. CVAP, CVAA, CPABN, CPAHM, CPAKM and CPATHA of January 2020 batch has successfully been completed. Now it is the time for final evaluation in particularly of practical papers. In view of the experiences gained in last three months following evaluation methodology is proposed for continuous assessment and final Term End Practical Examinations as per the followings:

Painting (CVAP) and Applied Art (CVAA)

Live video chat/performance: On a given day and time the Learner will display his entire

assignment and send a photo of the display. Based on display

a live interaction will be held with each learner.

Music (CPAKM, CPAHM) and Dance (CPABN)

Live video chat/performance: On a given day and time the Learner will be asked/given a task

(question) on the spot. S/he will answer/complete the task in

given time.

The TEPE will spread for few days.

Theatre Arts (CPATHA)

Live video chat/performance: The tasks (question) will be sent one week in advance to

individual learner. The learner will record the task performed on mobile and submit it on a given day in video form of 10minute duration for evaluation. Upon submission a live

interaction will be held with each learner.

Evaluation:

All evaluation shall be done by programme/ course coordinator with **no external examiner** for Jan 2020 and July 2020 sessions.

The item is placed for consideration and approval of School Board to expedite the conduct of TEPE.

Recommendation 25.09.1: The proposal to approve the modality of TEPE for Certificate programmes of SOPVA during Covid 19 pandemic was discussed at length. Programme Coordinators showed their concern to conduct TEPE on time as the Counselling and assignment process are already over/completed using technological means. The Board members were also apprised that a request to conduct TEPE as mentioned above has also been sent to PVC(SK) on 10.07.2020.

25.09.2: Majority of members including external experts appreciated and welcomed the idea of conducting practical examination using digital platform. Even they cited examples of their respective Universities/Institutes and were of opinion that as one-time measurement keeping in view of the ongoing situation the School should be allowed to conduct TEPE as proposed with External Examiner to maintain transparency and facilitate the learner during Covid-19 lockdown.

25.09.3: The two members from the University opined that neither there is precedence to conduct practical exams as proposed nor University have guidelines for such conduct and matter is a policy issue, hence suggested that the proposal may be submitted to the Vice Chancellor for taking decision and directions.

Item no 25.09: To consider and approve to withhold the Certificate Programme of Performing Arts – Karnatak Music (CPAKM).

NOTE

Certificate Programme in Karnatak Music (CPAKM) is being offered since the inception of the School. Since then the Programme is being coordinated by Dr. Mallika Banerjee, who is in fact a faculty of Hindustani Music. Though being under the big umbrella of Indian Classical Music, both the streams have their own identity due to language contents, techniques and terminologies; so a teacher of different specialization cannot do justification in its delivery. In 2011 a decision was taken to revise the programme, despite the above mentioned constraint the process of revision was initiated with the help of the external subject experts. Practical counselling of the students was being taken care of with the help of Academic Counsellor at different PSCs. However the programme never got good response for many reasons and the total number of students hardly reached double digit till date. At present, being a low enrolment programme it is being offered through WEAS and the counselling classes are being carried out by the Hindustani Music faculty of the School. The coordinator not being a subject expert neither can take practical counselling classes of Karnatak Music nor can communicate with the students in their native languages except for English. Further as per UGC regulation 2018 a programme with no subject teacher cannot be offered. Therefore, it is proposed to withhold the Certificate Programme of Performing Arts - Karnatak Music (CPAKM) till appropriate arrangements are made. The learning materials written for the programme will be utilized in the BA programme of Performing Arts under development having different approvals. The item is placed for consideration and approval.

Recommendation: T

The item was deliberated in detail. The School Board suggested that in the first instance School should ask for consultant/counsellor having Karnatak Music expertise to continue with the programme.
