Note

Indira Gandhi National Open University and Handloom, Textiles and Handicrafts Department (HTHD) under the Ministry of Culture of Government of Odisha has signed a generic Memorandum of Collaboration (MoC) to cater cultural, educational and socio-economical issues on 09th August, 2019. As follow-up of the MoC the Ist meeting of the Joint Monitoring & Implementation Committee (JMIC) was held on 26th August, 2019 at IGNOU HQs. In the meeting School of Performing and Visual Arts has been entrusted to develop some skill based Programmes in collaboration with HTHD to be offered through State Institute for Development of Arts & Crafts, Bhubaneswar, Odisha in the first instance. However, the programmes developed by SOPVA, IGNOU will on offered across the country through its Programme Study Centres.

The School Board (Item no. -24.03) approved Programme Proposal Form (PPF) for Diploma in Art and Craft (Pattachitra/Terracotta /Wood Carving /Stone Carving) in its 24th meeting held on 17th October 2019. Subsequently the Academic Programme Committee (APC) in its 59th meeting have considered and approved the PPF on 15th July 2020 (Item no. -05).

Pro Vice Chancellor Prof. Satyakam, while reviewing the progress of proposed programme in a meeting held on 15th September, 2020 observed that instead of Diploma the School should develop a Certificate programme in tune with the other School developing another programme in collaboration with SIDAC and directed to get a fresh approval of PPF for Certificate in Pattachitra from the School Board. This was also discussed in the JMIC (SIDAC+IGNOU) meeting held on 28th September 2020 chaired by Prof. K. B. Das, Pro Vice Chancellor.

In view of above a revised Programme Proposal Form (PPF) and Need Assessment Report for Certificate in Art and Craft -Pattachitra.are placed for consideration and approved of the School Board (Annexure II).
