This was further approved by 64th

APC with suggestive titles and approved by the 77th Academic Council as Bharatanatyam-Basics (BDNS-184) and Indian Art-Painting: An Introduction.

As recommended by CBCS, the course will adopt the same counselling and examination modality as followed in the CPABN and other Certificate Courses of SOPVA where online counselling and online practical examination is conducted by the in-house faculty. Other matters concerning evaluation methodology will be in tune with the other SECs of CBCS courses. The SLM for the course on dance shall consist of a Practicum Guide cum Journal (Bharatanatyam Basics) and for painting Study material for Indian Art-Painting: An Introduction will be prepared by the course coordinators.

NOTE

School has initiated Diploma in Theatre Arts programme from January 2021 session. At present this programme is offered in many study centres across the country under respective Regional Centres. But as per the admission data in some of the study centres the registered number of learners are less. Since this is a practical oriented programme it is difficult to conduct online counselling sessions and financially not feasible to conduct the sessions at respective study centres for less numbers. In this regard it is proposed to conduct a 7-10 days workshop at IGNOU Headquarters for each session if the number of learners are less in each study centre across the country. The workshop will be facilitate the learners with minimum number of counselling hours to complete their programme. The workshop will be conducted at PSC-087187 at SOPVA, New Delhi. In this regard, RSD in consultation with School has already issued the guidelines and notification (Annexure –III). The workshop will be conducted by core faculty and the Academic Counsellors approved for the PSC at SOPVA. After completion of the workshop the learners will appear for their term-end examinations for the practical courses.

The Master of Arts (Drawing and Painting) programme have been launched in July 2021 session with the following eligibility criteria for admission:

Bachelor of Arts - Drawing and Painting **OR** Bachelor in Fine Arts / Visual Arts **OR** Bachelor degree in Design/ Fashion Technology / Textile / Animation and other Fine/Visual arts concerned discipline.

In the addition to the above mentioned qualification for admission, few more qualifications were also proposed for approval.

Eligibility:

Bachelor of Fine Arts / Visual Arts **OR** Bachelor degree in Design/ Fashion Technology / Textile / Animation **OR** Bachelor of Arts (Drawing and Painting) **OR** Bachelor Degree with Painting as one of the subject **OR** Any Bachelor Degree with at least 3/5/7 year diploma Painting/Applied Art/ Sculpture/ Design/Commercial Art.

The item is placed before School Board consideration for approval.

Recommendation (SOPVA 30.15): The School Board Members approved the changes in the eligibility criteria in Master of Arts (Drawing and painting) MADP programme.

SOPVA 30.16: To consider and approve the proposal to adopt/adapt some of the units of Bachelor of Education (B.Ed.) for Master of Arts (Drawing and painting) MADP programme.

The some of the units of Bachelor of Education (B.Ed) are found useful for the MADP programme. They can be adopted/ adapted for the programme in MADP. In this regard, it is proposed to adopt the following units developed by School of Education.

School of Education Bachelor of Education (B.Ed.) Course: BESL 123 Block: Drama and Art in Education Unit1: Application of Drama and Art in Education Unit2: Drama and Art for Pedagogy Unit3: Drama and Art in Social Intervention

Recommendation (SOPVA 30.16): The School Board Members approved the proposal to adopt/adapt some of the units of Bachelor of Education (B.Ed.) for Master of Arts (Drawing and painting) MADP programme.

SOPVA 30.17: To consider and approve the online mode for term end examination of all the practical courses of BAPFHMH except the courses of the last semester.

The Programme of B.A Hons. in Music (BAPFHMH) is a limited enrollment programme, for which students have been enrolled different parts of the country. The counseling of theory and practical courses are being delivered through Headquarter using the WEAS platforms. Conventionally practical exams are held in presence of an external examiner where candidates are asked to perform individually and viva is taken regarding the Ragas and Talas prescribed in the syllabus.

As admission in this programme is scattered throughout the country it will be more viable to conduct the practical exams on online platform in the same way as we are conducting the Practical classes centrally through the online platforms. During the pandemic we have gathered enough experience to conduct practical exams on online platforms without any hassle.

So it is proposed to the School Board to consider and approve the online mode of Term End Examination for the 6 Practical courses those cover up to the 5^{th} semester of the BA Hons. Programme. However, in the last semester students will have to come to appear in person and perform to clear the last two practical Examinations. The code of the courses are as follows –

SOPVA has launched Master of Arts (Drawing and Painting) - MADP from July 2021session. The Master of Arts (Drawing and Painting) programme is offered only through PSC 07187P (Block 15G, First Floor, School of Performing and Visual Arts (SOPVA), IGNOU headquarter, Maidan Garhi, New Delhi) under Regional Center Delhi 1 on Pilot basis in ODL mode. In July 2021 session, 148 learners have been enrolled from different parts of the country. The counseling of theory and practical courses are being delivered through Headquarter using the WEAS platforms.

The evaluation methodology of MADP programme has already been submitted to the Student Evaluation Division (SED). The University has conducted the theory course MVA 020 Modern Art of India in TEE Dec.2021 (Semester 1). Now the school is planning to conduct Term end Practical Exam Dec 2021 under PSC 07187P/ RC Delhi. Hence, the scheme of conducting the practical examinations and its modalities, guidelines are as follows:
