At the outset, the Chairman of the School Board, School of Sciences, welcomed all the members present. Later, he took up the agenda items for consideration.

Item No. 1 : Approval of Evaluation Scheme for Laboratory Courses in the B. Sc. Programme.

SOS 7.1.1 : It was felt that the methodology of evaluation as well as the marking scheme needs to be more clearly spelt out. A Committee consisting of the following was constituted to formulate the proposal keeping in view the evaluation scheme being followed for laboratory courses in other schools.

If necessary, the committee may co-opt other members from the School.

Item No. 2 : Approval of additional course writers for courses in Life Sciences: LSE-05 (Genetics), LSE-09 (Animal Diversity-I), LSE-07 (Taxonomy) and LSE-10 (Animal Diversity-II)

- SOS 7.4.1 : The Board approved the list of paper setters, moderators and evaluators for the Mathematics Courses MTE-04 (Elementary Algebra), MTE-10 (Numerical Analysis) and MTE-11 (Probability and Statistics).
- Item No. 5 : Approval of change in the title of Mathematics Course MTE-04 from Basic Algebra to Elementary Algebra is sought in view of the fact that members of the Expert Committee in Mathematics have given their consent to this change in title of MTE-04.
- SOS 7.5.1 : The Board approved the change in the title of Mathematics Course MTE-04 from Basic Algebra to Elementary Algebra.
- Item No. 6 : Any other item with the permission of the Chair.
- Item No. 7.6.1 : Prof. Mandke suggested that each course team can have a long list ( a sort of global list) of course writers and get it approved so that approval of additional course writers from time to time can be avoided. This will be operationally very smooth. Further the list also can be arranged according to some priority.
- 7.6.2 : Prof. Shakti R. Ahmed expressed concern about delay in production of course material of Elective Courses in Science which has resulted in inordinate delay in their despatch and also loss of June, 1992 time slot for conducting laboratory courses.
- 7.6.3 : It was decided that the minutes of the last meeting of the School Board would be deemed to have been confirmed if no comments are received with a week's time.
