School Board's approval for the Scholar's extension was forwarded to Research Unit but extension to the candidate was not granted. The members deliberated on this issue and felt that adequate provisions be made in the Ph.D. Ordinance for granting one year's extension to the Ph.D. students without having to face the cumbersome processes, in vogue at present.

The members also enquired about the status of the BBA (Retail) Programme and related MoU, approved in the last meeting.

The Director explained the deliberations and discussions held with the competent authority. The competent authority directed that the whole programme be run solely by IGNOU and there is no need for further extension of MoU with RAI. The members, however, expressed their view for the continuance of such programmes having industrial linkage as its essential component. It was also pointed out that arranging internship for the students by the University will be extremely difficult without the help of RAI.

Members advised the Director that this matter should be taken up again with the competent authority for its continuance.

Yet the competent authority has directed the School to obtain specific approval of the eligibility criteria for admission into this programme from the statutory bodies again.

While deliberating on the renewal of the MOU between IGNOU and IIBF the members strongly felt that the programme having such useful linkage with the Industry should be encouraged.
