It was agreed that the PGDPPED programme is already on offer from July 2011, a comprehensive review of the curriculum is to be made through students and Study Centres. It was also mentioned that the School initiate development of Diploma in Pre-Primary Education through ODL mode. The programme details and other requirements will be as per NCTE model curriculum and its other norms and guidelines.

Item No. 33.2 To consider and approve the eligibility criteria for admission in Diploma in Elementary Education (D.El.Ed.) Programme as per the NCTE norms
