The Secretary (Ministry of Information & Broadcasting), Shri Ashok Bhaghat and Shri Atul Kantilal Nishar, Members could not attend the meeting.

Shri A.K. Gigoo, Assistant Registrar (Governance) was present to assist the Board.

At the outset, the Chairman, Board of Management (BoM), Prof. Nageshwar Rao, Vice Chancellor, IGNOU, welcomed all the members of the Board of Management in its 140th meeting held on 29th December 2020. He welcomed new members of the BoM, Prof. R.P. Das, Pro-Vice Chancellor; Prof. Jitendra Kumar Srivastava, Professor, School of Humanities: Prof. V. Subramanyam, Director, School of Computer & Information Sciences; and Dr. Bharat Bhushan, Director, Student Support Service Centre. The Vice Chancellor also appreciated significant contributions of the outgoing members namely; Prof. R.R. Kanhere, former Pro-VC; Prof. Poornima Mittal; Prof. Debal K. Singharoy; and Dr. Ranjan Kumar. The Vice Chancellor also welcomed external members of the BoM, Sh. Madan Mohan, ADG; Ministry of Education and Prof. S.G. Deshmukh in the meeting. The five members of the BoM namely; Prof. R.P. Das, Pro-Vice Chancellor; Prof. K. K. Aggrawal; Prof. V.S. Prasad, Dr. Subha Sankar Sarkar and Dr. P. Prakash attended the meeting through virtual mode. The Vice Chancellor also welcomed and thanked them for attending the meeting online.

In his introductory remarks, the Vice Chancellor informed the Board that during Covid-19 lockdown, the University tried its best to maintain academic activities of the University including online admissions and nationwide term end examinations.

The Vice Chancellor illustrated the significant developments of the University since the last meeting of the BoM and these were:

- (1) Hon'ble Minister, MoE, Sh. Ramesh Pokhariyal 'Nishank' launched two online PG programmes in MA Hindi and MA (Gandhi and Peace Studies) and a few certificate courses.
- (2) Hon'ble Minister, MoE inaugurated the construction work of Karnal Regional Centre on 21st August 2020. We are extremely grateful for his kind encouragement.
- (3) NAAC Visit: 5-7th January 2021. IGNOU is the first Open University to be visited by NAAC Peer Team for accreditation. The Chairperson requested the BOM members to support and guide the University in this process.

(4) **Term End Examinations:**

- a. The theory examination commenced from 17thSeptember 2020 and completed on 17thOctober 2020.
- b. Around 3.64 lakhs students had registered for these examinations out of which around 60% students appeared for the examinations.
- c. The practical examination and project evaluation/ viva-voce were conducted subsequently through online mode.
- d. Scheme for the promotion of intermediate year/ semester students is notified.

(5) Admission:

- a. July 2020 Fresh Enrollment (4.87 lakhs): University achieved over 80% of fresh enrollment of July 2019 (5.40 lakhs)
- b. July 2020 Re-registration (**3.49 lakhs**): University has already crossed the enrollment of the previous session (i.e. 3.21 lakhs July 2019)
- c. 15 new online programmes including MA Hindi have more than 2300 enrollments;
- d. Fee waiver scheme of the University for SC/ST students has also benefited around 75000 students for the current admission session i.e. July 2020 session.

- (6) **NCIDE: IGNOU received Five Star rating for Innovations and Startup** by the Ministry of Education's Innovation Council (MIC) for the year 2020. Last year, it was two star rating for the University.
- (7) Centre for Online Education (CoE): For July 2020, Fifty two (52) new courses were launched on SWAYAM and total courses offered by the University rose to 73 courses. Total enrollment for SWAYAM Courses (July 2020): Over 1.5 lakhs
 - a. 8 to 10 SWAYAM courses have enrollment ranging from 5000 to 8000.
 - b. Additional **15 new standalone courses** would be launched from January 2021 session.
 - c. Translation of 11 SWAYAM courses completed and process of translation of remaining 5 SWAYAM courses has been going on.
- (8) Centre for Gandhi and Peace Studies (CGPS) launched a new two (02) credit online course on *Relevance of* Sardar *Vallabhbhai* Patel *in the Contemporary World*, developed on the request of Department of Personnel & Training, Govt. of India. A two (02) credit course on Relevance of Gandhi in the Contemporary World (RGCW) in collaboration with DoPT was already on offer.
- (9) **MPDD:** The dispatch of printed study materials for January 2020 **session** has been **completed**. For July 2020 session, around 50% dispatch of printed learning materials has been completed.
- (10) **HEFA loan for Construction of Regional Centre Buildings:** HEFA **loan** for **construction** of RC buildings at Pune, Rajkot, Trivendrum, Port Blair, Bangalore and NOIDA. MoU has been signed with CPWD for construction of Administration and RC buildings.
- (11) Solar Energy: Installation work of 500 kWp solar panel was commenced on 15th August, 2020. The Solar Panel was switched on 19th November, 2020 (Foundation day). The University is expected to save around Rs. 30 lakhs per annum using solar energy.

(12) Student Support during Covid 19 Pandemic:

- a. Several thousands of online counselling sessions through video conferencing app such as Zoom, Google Meet, Webex, Gyan Darshan, Gyanvani and Facebook Live were conducted by Hq and most of the Regional Centres.
- b. To facilitate the students, a country wide consolidated online counselling schedule was uploaded on daily basis on the social media platform of the university.
- c. Assignments of the students were allowed to be submitted through dedicated mail ids of the Regional Centres and through online google form;

- (13) **International Delegation from Republic of Guyana:** A MoC was signed between IGNOU and National Open Learning Institute (NOLI), Republic of Guyana on 2nd December 2020 for providing consultancy to NOLI Guyana for the institutional development to offer Online and ODL programmes; and facilitating to offer Online Programmes through twenty thousand scholarships dedicated by NOLI to students of Guyana.
- (14) **Finance and Accounts:** Balance Sheet of the financial year 2019-20 has been prepared and the same has been audited by Director General of Accounts (Civil Estimates) DGACE team. Audit observations on certification audit are expected to be received very soon. Once the Audit Observation is received, the University shall submit its comments and thereafter, the Separate Audit Report (SAR) shall be issued. It is expected that SAR will be received by 15th January, 2021. The same shall be presented before the BoM shortly thereafter, after the consent of Finance Committee.

Revised Budget Estimates for the year 2020-21 and Budget Estimates for 2021-22 have been prepared. The same is under process for presentation before the Finance Committee. The Finance Committee Meeting shall be convened soon after the receipt of SAR from DGACE. There is a shortfall in revenues by Rs.180.31 Crores on comparison to proposed revised estimates.

After the above prefatory remarks, the Secretary, BOM presented the following Agenda:

ITEM NO. 1 TO CONFIRM THE MINUTES OF 139TH MEETING OF THE BOARD OF MANAGEMENT HELD ON MARCH 17, 2020 AND TO NOTE THE ACTION TAKEN REPORT THEREON

- **BM 140.1.1** The Secretary informed the Board that the Minutes of 139th Meeting of the Board of Management held on 17.3.2020 were circulated to the members of the Board on 20.3.2020. No comments were received from the members on the 139th BOM minutes.
- **BM 140.1.2** The Board confirmed the Minutes of the 139th Board Meeting and also noted the Action Taken Report thereon.
- **BM 140.1.3** The Board also directed to present the details of ATRs for which action taken was pending.

ITEM NO. 2 TO REPORT THE NOMINATIONS OF FOUR MEMBERS MADE ON THE WORKS COMMITTEE, A STANDING COMMITTEE OF THE BOM UNDER CLAUSE (3) OF ITS

COMPOSITION

BM 140.2.1 The Board noted the nominations of four members made on the Works Committee, Standing Committee of the BOM, under Clause (3) of its composition.

ITEM NO. 3 TO CONSIDER NOMINATIONS OF FIVE MEMBERS ON THE PLANNING BOARD UNDER STATUTE 10(1) OF THE CLAUSE (IV) OF THE IGNOU ACT

- **BM 140.3.1** The Board authorized the Vice Chancellor to nominate the members on the Planning Board under Clause (iv) of Statute 10(1) of the Statutes of the University under IGNOU Act.
- ITEM NO. 4 TO REPORT THE LETTER RECEIVED FROM MHRD REGARDING THE COMPLAINT IN RESPECT OF PROF. PARVIN SINCLAIR, FORMER DIRECTOR, NCERT PRESENTLY WORKING AS PROFESSOR IN IGNOU
- **BM 140.4.1** The Board noted that the MOE vide its letter dated 7.7.2020 addressed to Director, NCERT informed therein that the Competent Authority in the MOE in consonance with the advice of CVC had decided to drop the charges against Prof. Parvin Sinclair.
- ITEM NO. 5 TO RATIFY THE SIGNING OF MOA WITH TWO NEWLY RECOGNIZED OVERSEAS STUDY CENTRES AT BAKHTAR UNIVERSITY, KABUL, AFGHANISTAN AND CENTRAL ASIAN INDIAN INSTITUTE OF DISTANCE EDUCATION (CAIIDE), INTERNATIONAL UNIVERSITY OF KYRGYZSTAN, KYRGYZSTAN
- **BM 140.5.1** The Board noted that as per the approval of the Visitor conveyed by the MOE vide its letter No.5-28/ 2014-DL(pt.) dated 11.02.2019 for recognition of fourteen institutions as Overseas Study Centres of the University, MoAs have been signed with the following two institutions on 8.11.2019 & 29.11.2019 respectively and ratified the same:
 - 1. Central Asian Indian Institute of Distance Education (CAIIDE), International University of Kyrgyzstan, Kyrgyzstan.
 - 2. Bakhtar University, Kabul, Afghanistan
- **BM 140.5.2** Prof. V.S. Prasad while highlighting the importance of international operations of the University especially as also emphasized in the

National Education Policy, stressed upon the need for timely processing of applications which at present has been taking undue long time.

Approval of the Visitor is to be taken for establishing Study Centres outside India as per the IGNOU Act. It was also discussed that Overseas Study Centres are at present not established but only recognized.

The Vice Chancellor said that the Ministry is looking into this issue and a detailed note will be sent to Ministry in this regard.

ITEM NO. 6 COLLABORATION TO CONSIDER THE WITH THE GOVERNMENT OF **GUYANA** FOR **OFFER** OF EDUCATIONAL/ TECHNICAL PROGRAMMES UNDER THE SCHOLARSHIP SCHEME

BM 140.6.1 The item was taken up for consideration. The Board was informed that the Joint Secretary (Parliament & Coordination), MEA and Prof. Jacob Opadeyi, consultant, MOD, Republic of Guyana have forwarded proposals to IGNOU for collaboration with the Govt. of Guyana for providing educational/technical programmes. As highlighted in the proposal, Govt. of Guyana's priority was to provide 20,000 online scholarships to its learners over the next five years in its quest to improve educational skills and capacity building among the youth of Guyana. In order to achieve this objective, Govt. of Guyana was of the view that IGNOU would be the best option for collaboration with the University of Guyana, for providing up to 5,000 slots for its students per year under a It was further informed that the High scholarship scheme. Commissioner of India in Guyana H.E. Dr. K.J.Srinivasa has suggested IGNOU to consider providing around 2000 slots on gratis basis or offering specially subsidized rates for the total 20,000 slots as an incentive to promote Indo-Guyanese cooperation in the education sector and support the long-term scholarship scheme of Govt. of Guyana.

> The Board noted that a delegation from Guyana visited IGNOU Hqrs. on a Study Tour recently to explore collaboration with the University to officer online/ODL programmes to the Guyanese learners. The delegates also had the opportunity to visit one Regional Centres and one Study Centre to understand the operational aspects of student support services. The Board also noted

that after deliberations, the following mutually acceptable points were agreed upon for the collaboration between IGNOU and National Open Learning Institute (NOLI), Guyana:

- IGNOU to provide consultancy to National Open Learning Institute (NOLI), Guyana for the Institutional Development to offer Online and ODL programmes;
- IGNOU to conduct capacity building programmes for NOLI and other tertiary institutions of Guyana;
- IGNOU to conduct training and orientation of NOLI, Guyana functionaries at mutually agreed place and mode (online / face to face);
- IGNOU will facilitate to offer online programmes for 20,000 scholarship students of Guyana; and
- IGNOU and NOLI to explore additional areas of mutual cooperation.

Accordingly, a generic Memorandum of Collaboration (MOC) was made between IGNOU and NOLI, Georgetown, Guyana on 02.12.2020 for execution of the operational framework of this collaboration.

- **BM 140.6.2** The Board considered the collaboration with the Govt. of Guyana and directed to process the collaboration as per the laid down procedure expeditiously.
- ITEM NO. 7 TO RATIFY THE RECOMMENDATIONS OF THE STUDENT SERVICES COMMITTEE (SSC), A STANDING COMMITTEE OF BOARD OF MANAGEMENT MADE AT ITS 48TH MEETING HELD ON 01ST SEPTEMBER 2020
- **BM 140.7.1** After discussions, the Board ratified the decisions taken on the recommendations of the Student Services Committee, a Standing Committee of the BOM made at its 48th meeting held on 01.09.2020.
- ITEM NO. 8 TO CONSIDER AND APPROVE RECOMMENDATION OF THE VICE CHANCELLOR FOR NOMINATION OF MEMBERS TO THE ACADEMIC COUNCIL UNDER CLAUSE (1) (IV), (VI) AND (IX) OF STATUTE 9 OF THE UNIVERSITY
- **BM 140.8.1** The Item was taken up for consideration. The Board authorized the Vice Chancellor to nominate the members on the Academic Council of the University under Clause (1)(iv),(vi) & (ix) of Statute 9 of the

Statutes of the University under IGNOU Act.

- ITEM NO. 9 TO REPORT THE APPROVAL OF THE VISITOR TO THE PROPOSAL OF IGNOU ON (I) ORDINANCE FOR CAREER ADVANCEMENT SCHEME OF TEACHERS, AND (II) ORDINANCE FOR CAREER ADVANCEMENT SCHEME OF ACADEMICS INCLUDING LIBRARIAN OF IGNOU BASED ON "UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018"
- **BM 140.9.1** The Board noted that as per the approval of the President of India in his capacity as Visitor of the University, conveyed by the MOE vide its letter No.F.5-39.2012-DL dt.15.9.2020, the University had notified the (i) Ordinance for Career Advancement Scheme of Teachers and (ii) Ordinance for Career Advancement Scheme of Academics including Librarian, vide notification No.F.IG/ACD/ 7thCPC/CAS/2019-20/06 dt.18.9.2020.
- **BM 140.9.2** The Board further resolved to put on record its appreciation to officers of the University Grants Commission, officers of Ministry of Education and Director, ACD for their support in getting the Ordinance approved in a time bound manner.

ITEM NO. 10 TO RATIFY THE ACTION TAKEN BY THE VICE CHANCELLOR IN APPOINTMENT/GIVING CHARGE OF DIRECTORS OF SCHOOLS/DIVISION/CENTRE/UNIT

BM 140.11.1 The Board was informed that the University had conducted the Selection Committee meetings for appointment to the posts of Professors and Associate Professors in the Discipline of Sanskrit and Political Sciences, in the School of Humanities and School of Social Sciences, respectively. As regard the post of Professor of Sanskrit (1SC), in the School of Humanities, the opening of envelop was deferred.

- **BM 140.11.2** The Board confirmed this Item for implementation and directed that Appointment Orders be issued accordingly. The Board directed to issue the Part-Minutes in this regard.
- ITEM NO. 12 TO CONSIDER THE MATTER RELATED TO RECRUITMENT OF TEACHERS AS PER VACANCIES ADVERTISED FOR FILLING UP OF THE VACANT POSITIONS OF TEACHERS AND ACADEMICS IN THE UNIVERSITY
- BM 140.12.1 The Board was informed that the DoPT OM as per No.36039/1/2019-Estt.(Res.) dt.31.1.2019 and MOE letter No.F.12-1/2019-DL dt.01.5.2019 regarding reservation for Economically Weaker Sections in direct recruitment in Civil posts and service in India. the University had advertised (vide Govt. of Advt.No.03/2019/ACD dt.21.9.2019) the teaching positions at the level of Professor, Associate Professor and Assistant Professor (vide Advt.No.02/2019/ACD dt.28.9.2019) in the Employment News. The applications were invited Online through Online Portal designed in consultation with SAMARTH. In response to the advertisements, the University received 5152 applications and all the applications received online/hard copies were sent to respective Schools of Studies for screening the same in accordance with screening criteria and as per the provisions contained in the UGC Regulations on Minimum Qualifications for appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018 including UGC guidelines on list of Journals etc. The Vice Chancellor had also constituted a Standing Screening Committee having due representation of School Director and Senior Professor in the discipline/from School for screening the applications for teaching positions in order to bring uniformity and further screen the

applications. The Board observed that as on date, Selection Committees have been conducted for 5 posts under 2 Disciplines and that because of lockdown due to COVID 19, almost 7-8 months were lost. A large number of applications, especially against the posts of Assistant Professors, were required to be screened and the process of selection (against the posts advertised) was likely to take more time. Therefore, the validity of advertisement would be required to be extended by one year i.e. upto 31.10.2021 so that the selection process may be completed. It was also observed, that there have been certain posts against whom the number of applications received were very few and in turn a few candidates could be shortlisted. Therefore, in order to give a fair chance of competition, there was a need to decide a minimum number of shortlisted candidates for convening the selection committees.

BM 140.12.2 The matter was deliberated at length. The Board, after detailed deliberations, decided to extend the validity of Advertisement upto 31.10.2021 to complete the selection process. Regarding the minimum number of candidates shortlisted, the Board advised to follow the convention and authorized the Vice Chancellor to take other appropriate decisions relating to recruitment process.

ITEM NO. 13 TO REPORT THE SIGNING OF MOU BETWEEN IGNOU AND THE INSTITUTE OF COMPANY SECRETARIES OF INDIA (ICSI) FOR ACADEMIC COLLABORATION

- **BM 140.13.1** The Board noted the signing of an MOU with Institute of Company Secretaries of India (ICSI) for academic collaboration.

- **BM 140.14.1** The Board ratified the action taken by the University in allowing switchover of 26 employees from CPF to GPF cum Pension Scheme and release of pension/commuted value of pension arrears to the retired employees covered under switchover.

- **BM 140.15.1** The Board noted the action taken by the University in extending the tenure of EOL cum deputation of Dr. Sanjay Kant Prasad, Dy. Director, NCDS presently working as Deputy Chief Commissioner in the Office of the Chief Commissioner for persons with Disability (Divyangjan) for a total period of five year till March 2021.
- ITEM NO. 16 TO CONSIDER THE REPORT/FINDINGS SUBMITTED BY THE INQUIRY OFFICER IN RESPECT OF CHARGE-SHEET ISSUED TO DR. PANKAJ KHANNA, DY. DIRECTOR, PLANNING & DEVELOPMENT DIVISION FOR PLAGIARISM CHARGES AGAINST HIM
- **BM 140.16.1** The Board noted the directions of the BOM in its 130th meeting held on 8.9.2018 for initiating disciplinary proceedings against Dr. Pankaj Khanna, Dy. Director in the matter of plagiarism charges against him. The Inquiry Officer appointed in his case had submitted the findings alongwith all supporting documents on 6.3.2020. The findings of the Inquiry Officer was placed before the Board for consideration. In the findings of the Inquiry Officer, it has been established that Dr. Pankaj Khanna has plagiarized the article to the tune of 55%. The IO further mentioned that any decision on the case needed to be taken into account while deciding the level of penalty as rendered to the co-author Prof. P.C. Basak who was equally responsible for the article.
- **BM 140.16.2** The matter was discussed in detail. The Board decided to award the following punishment to Dr. Pankaj Khanna:
 - (i) Dr. Pankaj Khanna be served with a stern warning for act of plagiarism.
 - (ii) The date of eligibility for promotion to Dr. Pankaj Khanna under CAS be postponed by one year from the date he become eligible and found successful for promotion by Selection Committee. During this period of deferment he will

not be given any benefit of financial or otherwise including seniority and the same shall be regulated on expiry of said period, by granting the benefits prospectively.

ITEM NO.17 TO RATIFY THE CHANGES MADE IN THE EXISTING IGNOU HOUSE ALLOTMENT RULES

BM 140.17.1 The Board ratified the changes made in the existing IGNOU House Allotment Rules under Clauses 8.3, 11.2, 15.2 & 22.1 notified on 31.8.2020 & 22.9.2020.

- **BM 140.20.1** The Board ratified the action taken by the Vice Chancellor in accepting the request of Dr. Meeta, Assistant Regional Director, RC Patna for joining Nava Nalanda Mahavihrara, Nalanda, Bihar as Associate Professor in the Department of English and granting her lien of two years against her substantive post in IGNOU.
- ITEM NO.21 TO CONSIDER THE MINISTRY OF EDUCATION LETTER DATED 21.12.2020 REGARDING THE ITEMS INVARIABLY TO BE INCLUDED IN THE AGENDA ITEMS OF FINANCE COMMITTEE(FC)/BOARD OF MANAGEMENT (BOM)/BOARD OF GOVERNORS (BOG) OF HIGHER EDUCATIONAL INSTITUTIONS (HEIS)
- **BM 140.21.1** The Board discussed the contents of the MOE letter No.F.5-21/2020-DL dt.21.12.2020 (**Appendix**) regarding the Items invariably to be included in the Agenda Items of Finance Committee (FC)/Board of Management (BoM)/Board of Governance (BoG) of Higher Educational Institutions (HEIs). The Board also noted the status of outstanding paras as per Inspection Report issued by the DGACE, CAG and status of grievances received and disposed on iGRAM Portal PG Portal. As per the suggestions given by the MOE, the Board resolved as under:

It was further suggested that the status of vigilance cases pending in the University may also be brought to the notice of the Board of Management regularly.

ITEN NO.22 TO CONSIDER THE MINUTES OF THE SCREENING CUM EVALUATION COMMITTEE FOR PROMOTIONS OF TEACHERS AND ACADEMICS UNDER CAREER ADVANCEMENT SCHEME (CAS)

BM 140.22.1 The Board was informed that the University had conducted "Screening-cum-Evaluation Committees" for Career Advancement of Teachers and Academics of the University as per Ordinances on Career Advancement Scheme of Teachers and Ordinances on Career Advancement Scheme of Academics as per UGC Regulations, 2010 alongwith subsequent amendment thereto under 6th CPC, and UGC Regulations, 2018 under 7th CPC. The recommendations of the Screening-cum-Evaluation Committees were placed before the Board for consideration. ITEM NO.23 TO REPORT THE INITIATIVES OF THE UNIVERSITY FOR NAAC ACCREDITATION AND TENTATIVE VISIT OF THE NAAC PEER TEAM TO THE UNIVERSITY IN JANUARY 2021

BM 140.23.1 The Board was informed that as per the ODL Regulations, 2017, it was mandatory for the University to apply for Assessment and Accreditation (A&A) by the NAAC within one year of the launch of the NAAC Manual for Open Universities, which was released on 29th April, 2019. The institutional data was filled up in the IIQA format on NAAC portal and submitted on 16.10.2019. The queries raised on IIQA by NAAC were also responded to, based on which NAAC approved the IIQA of the University on 9.1.2020 and asked IGNOU to submit its Self Study Report (SSR) within 45 days. On receiving the IIQA acceptance, the University uploaded the Self-Study Report (SSR). Under the chairmanship of Hon'ble Vice Chancellor a series of meetings were held with the PVCs, Directors/Registrars/ Finance Officer/ Head and Senior Professors of the University, to finalize the SSR before final submission on NAAC Portal online. After paying the initial payment of SSR to NAAC the finalized SSR of IGNOU after detailed discussion and consultations; selecting non-applicable metrics was successfully submitted to NAAC on 7th March 2020.

It was further informed that Post-SSR submission, all the

data/information submitted by IGNOU was validated through the Data Validation and Verification (DVV) process. The data/ information submitted by IGNOU in its SSR was validated through the Data Validation and Verification (DVV) process by NAAC. The NAAC had raised 11 queries pertaining to the Extended Profile and 58 to the metrics. The University submitted its response clarifying the issues raised by the DVV team on 13th July 2020, well in time. The Student Satisfaction Survey (SSS) was started by NAAC on 19th March 2020 and completed on 31st August 2020. On 08th December, 2020 NAAC had communicated to the University that IGNOU has pre-qualified the SSR. The final payment for Accreditation application was made by the University on the NAAC portal on 8th December, 2020.

The Chairman apprised the Board that the NAAC Peer Team will be visiting the University from 5th -7th January 2021; 02 Regional Centres and 04 Learner Support Centres on 02nd January 2021 prior to the Visit to the Hqrs.

BM 140.23.1 The Board appreciated the initiatives of the University for NAAC Accreditation and noted the tentative visit of NAAC Peer Team to the University.

ITEM NO. 24 TO CONSIDER THE MATTER RELATED TO RECRUITMENT TO THE POSTS OF REGISTRAR (MPDD) AND ASSISTANT REGIONAL DIRECTOR, RC SRINAGAR (ON DEPUTATION)

BM 140.24.1 The Item was taken for consideration. The Board approved the proposal for re-advertisement of the positions of Registrar (MPDD) and Assistant Regional Director, RC Srinagar (on deputation) afresh, since more than a year has passed when the Selection Committees for these posts were constituted and more than one & half year since advertisement.
