Sir,

In continuation to letter, F No. 1-1/2018(DEB-II) dated 08.08.2019 on the subject mentioned above, I am directed to inform you that the UGC vide F.No.1-1/2018(DEB-II), Commission in its 543<sup>rd</sup> meeting dated 09.08.2019 has decided to exempt the Indira Gandhi National Open University, a University established under the Indira Gandhi National Open University Act,1985(50 of 1985), from the application of University Grants Commission Open and Distance Learning) regulations,2017 and its amendments, from academic session 2019-20 till further orders.
